Dear Sisters,

Our October 3 meeting will take place at Memorial United Methodist Church in the Fellowship Hall. Pi's executive board will once again be serving a homemade Italian meal as a fund-raiser, the money raised going toward our Vera Jo Henegar DKG Grant Award presented to two high school seniors who plan to pursue degrees in education. The meal will begin at 5:00. The door will be open before 4:15, earlier if needed.

Committee chairs, please contact your members about conferencing with you at the meeting. Some of our committees have already met, so are not included in the following list of committees: Membership, Archives/Scrapbook, Rules, Nominations, Elementary and Middle School Essay Contest, and Special Events. I know that when I have chaired different committees, I have found that the time for the business of the committee to be completed can sneak up on you. We have some big events and responsibilities coming up this year.

At the September meeting, the members in attendance voted to raise the Vera Jo Grants from \$500 to \$750 each. It was felt that we might be able to fund the extra amount needed by increasing what we put in the Happy Jar by a little each month. The following is a history of the grant dollar amounts: 1975-1996, varying amounts between \$0 and \$150; 1997-1998, \$200; 1999-2000, \$300; 2001, \$400; and 2002-2022, \$500.

In September, Amanda presented a program about Tennessee Achieves and her experience with this organization. Several of our members have been mentors. Patsye is even listed in last year's handbook as having served for 10 years. Tennessee Promise and Tennessee Achieves partner as they provide a scholarship and a mentoring program focused on increasing the number of students who attend a postsecondary institution in our state. The class of 2023 at ACHS had 265 students with 220 applying to TN Promise; CHS had 250 seniors with 240 applying to TN Promise. Last year, only 83 percent of the goal for the number of mentors for the three high schools in Anderson County was achieved. The website, tnachieves.org, has a wealth of information about the commitment involved. It has been said that being a mentor takes only one hour per month. (*continued on next page*)
